Attorneys wishing to set matters for hearing in cases assigned to me may do so according to the attached schedule. It will not be necessary to obtain a date and time from the calendar clerk unless otherwise noted.

Cases assigned to me contain the letter "B" immediately following the case number. If the letter "A" follows the case number it is assigned to Judge Ford.

Following the "A" or "B" designation will be a number representing the Bankruptcy Code chapter under which the case is pending, followed by an "F" or "K." Cases with the "F" designation are to be set for hearing in Fresno. Cases with the "K" designation are to be set for hearing in Bakersfield. If there is no "F" or "K", use the city of the first meeting of creditors to decide the hearing location.

The calendar clerk will enter the hearing on the calendar upon the filing of the notice of hearing. IT IS ESSENTIAL THAT THE NOTICE OF HEARING BE FILED AS SOON AS SERVICE IS COMPLETED.
